# Board of Trustees Business Meeting Minutes November 16, 2021 (6:30-8:30 pm) via Zoom

In attendance: Becky Densmore, Jody Hanger, David Gross, Brian McDermott, Mick McEnroe (guest), Rev. Karen Bush, Jennifer Ellis, Lan Richart, Rev. Sally Fritsche (left at 7:25 p.m.), Jerry Frye (joined at 6:50 p.m.)

Meeting called to order at 6:33 p.m.

### Chalice Lighting and Ministerial Offering - Rev. KB

The agenda for the evening was finalized with no changes.

#### **Consent Agenda**

- The Board received reports from the Consulting Minister, the Associate Minister of Congregational Life, the Director of Congregational Administration, the Consulting Minister fo Religious Exploration and Engagement, and the Coordinator of Religious Education and Engagement
  - Densmore noted the concern about Adult Choir being in limbo; KB choir director will be at the next COVID Task Force mtg.
  - O McDermott applauded Franklin for new rose window idea and bringing in the congregation
  - Hanger asked whether REE team concerned about low attendance at recent events; KB weather really got in the way, looking forward to meeting in small groups; McDermott - beneficial to OWL to meet in person in the church, kids doing a great job following COVID safety protocols
- The Board received minutes from the 10/19 BOT Special Session Business Meeting
- The Board received minutes from the 10/26/21 BOT Business Meeting

The consent agenda was accepted unanimously without revision.

  - o good that COVID group is meeting in the middle of the month
  - wonderful congregation and spectacular staff!
- Oral Report on Monthly Financials for October 2021 Lan Richart

- Hard to discern trends, but October not a good month, ⅓ of fiscal year,
- \$19,799 in pledges is the lowest in the past 14-16 months, general donation and plate collections were \$1725, income \$21,632 substantially down,
- Expenses lower than average, but still \$44,769.

- Pledges \$20,417 below budgeted amount through this point of the year.
- Need to watch what happens in the next few months, things have been a bit soft.

#### **OLD BUSINESS**

• Action/Discussion: Staff Covid Vaccination Policy

**DRAFT MOTION:** Based upon the guidance and recommendation of the Personnel Committee, the BoT recommends adoption of the Covid Vaccination Policy and directs its immediate execution upon the BoT majority approval.

**Resource: Covid Vaccination Policy** 

Gross moved to accept the motion as written: the heart of the motion is to have our staff vaccinated, those who choose to work for the church should be vaccinated. Hanger seconded.

#### **Discussion:**

- Ellis fully supports the idea for all staff to vaccinate, but has serious concerns
  - is the church being compliant with the ADA and Civil Rights Act
  - why no religious exemption?
  - exemption should be signed by supervisor, not physician may violate HIPAA
  - requiring a negative test to return to work doesn't follow science CDC has different criteria because people may have positive results for months after they recover
  - has problem with Board wordsmithing the Personnel Committee, Chief of Staff need to use their expertise to put their attention to legality and inclusion
- Densmore everyone wants a valid policy; the Personnel Committee tried to get it right
- o Frye is it known whether anyone consulted the UUA? Agreed that there are legalities involved
- Gross policy has been discussed at length in the Personnel Committee and thinks he they have reached out
- Ellis did further digging, there is a great website on UUA, has really good information about such issues as:
  - Can we require staff to be vaccinated?
  - Has sample policies and things to consider
- Ellis doesn't think we can specify medical or religious exemption
- O Densmore can we vote on the DRAFT version and ask Personnel to get it reviewed?
- O Gross- Personnel has worked hard on this and they want a vote on it
- O Richart it's not a policy if we just approve a draft; BOT trusts the Personnel Committee, but Ellis has good points; we need to have a legal and appropriate policy
- Frye- shares Ellis's concerns
- McDermott- agree with Ellis comments and concerns, particularly about having religious exemption being an option, appreciates the Personnel Committee's work on this, but it needs legalistic evaluation
- McEnroe (via Zoom Chat) agrees with Ellis and Frye; maybe the Personnel Committee would benefit from Ellis's resources

Vote was one in favor of accepting the Staff COVID Vaccination Policy as written; six voted against the draft policy.

- Ellis will forward her concerns and resources to the Personnel Committee
- McDermott suggested that Brian Franklin, DCA could be a good resource for getting info from the UUA

• Action/Discussion: COVID Advisory Taskforce

**MOTION:** The Board of Trustees affirms the SLT's (Staff Leadership Team) recommended specific and immediate exception to UUCUC's reopening framework that would allow for the small youth class Taking Flight (our current Our Whole Lives/OWL sexuality education program) to meet indoors at UUCUC on Sundays from 4-6pm.

Resource: The SLT's response to "why?"

O Why this specific and immediate exception? Our Whole Lives is critical and time sensitive and cannot take place online, it can only happen in person. Offering an exception to have them meet on-site and inside is integral to Taking Flight running successfully. Every other small group that we offer currently can meet online, and is not time sensitive in the many ways that this program is (these youth are actively in puberty, exploring their sexuality, and being exposed to harmful sex ed. online and in their schools).

McDermott moved to accept the motion as written; Frye seconded. Vote is unanimous; motion to affirm the SLT's decision to allow the youth OWL program to meet inside the church.

#### **NEW BUSINESS**

• **Discussion**: Staff Holiday Recognition

**Resource: Personnel Committee Proposal** 

Resource: Finance Committee could not find the resources and provided the following guidance:

- Very tight budget year concerns related to finishing the year balanced in terms of revenue and expenses
- o Cuts have been made to accommodate expenses related to ministerial medical leave
- Committee expressed concerns with modifying an approved congregation budget without a critical need to do so. In this instance, we would be taking money from approved congregation expenses to cover one that was not.
- Personnel Committee suggested a gift card instead of a paycheck bonus
- McDermott bonuses traditionally given to staff more at the end of the church year; not planned or put into budget
- Frye might be something available later in the year
- McEnroe suggested a card shower
- Richart suggested alternative ways to show appreciation; difficult decision but supports the Finance Committee's response
- KB the important part is being remembered
- McEnroe maybe a "staff appreciation day" when it's warmer and safer
- Densmore agrees with the Finance Committee's suggestions
- News: Immigration Justice Task Force (IJTF) Hospitality Planned

Resource: <u>IJTF Approved Hospitality Amendment</u>

- Densmore the IJTF educated and followed up with staff about immigrant family arriving;
- Richart IJTF found out from the Refugee Center that Afghan family arriving Saturday and needs temporary space for 5-7 days; will stay in the YRUU room and exit through side doors; won't be near any staff; may not even be around very much as they work with the Refugee Center; no ICE involvement
