MOTION: At the recommendation of the Generosity Committee, the Board hereby approves a campaign to solicit commitments to the Associate Minister Set Aside fund as part of the FY23 Generosity Campaign.

Gross moved to accept motion as written; Beckett seconded

Discussion:

- Densmore there was concern about the lack of support for Rev. Fritsche in the budget; that's why
 decision was made
- McDermott, Hanger, Ellis worried that it looks like Rev. Fritsche is separate from the budget makes her job seem temporary
- Ellis concerned that pledges might be split and that general pledge will be reduced; are we voting for Rev. Fritsche's job status with money?

Mona Shannon joined the discussion at 7:22 p.m.

- Shannon financially she still is temporary; we do not have sustained budget to keep 1½ ministers
 - o ; we gave ourselves two years to grow into position, but then COVID
 - o renewing commitment to position despite that we haven't grown at the rate that we hoped
 - o the leap was bigger than what we thought; let people speak through their hearts
 - o it is a tried and true mechanism for funding and fundraising
 - o making it transparent that we are not there yet to have her be a part of regular budget
- Ellis for those who don't have extra, is it problematic to make them have to choose between Rev. Fritsche or the general pledge?
- Shannon set aside fund really just a name; the funds will be used for Rev. Fritsche in the next fiscal year if we get more than that or general pledges are affected, she can talk with donors
- Gross supports the proposal, a good way to raise money it to spotlight the most attractive feature
- Richart make sure that Rev. Fritsche knows she is going to be highlighted on form
- Densmore change form to read "Associate Minister (Sally Fritsche) salary and benefits" for clarity
- Densmore Mona and KB believe that people are just waiting to be asked

Vote was unanimous; the motion to approve a campaign to solicit funds for the Associate Minister Set Aside as part of the FY23 Generosity Campaign passed.
