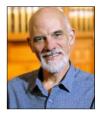

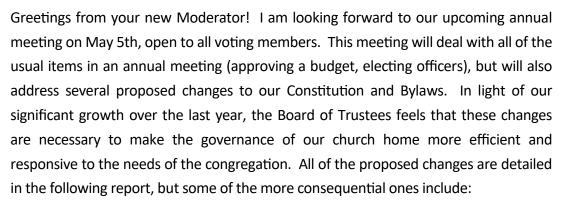

- Amending the Constitution to make explicit that the minister is the Chief of Staff for the church, meaning that the minister has the ability to hire and discharge staff. The minister has functioned as the Chief of Staff for some time.
- Modification of the Bylaws's definition of the duties of the Financial Secretary to make it more manageable for the volunteer in that position, including electing a third Trust Fund Trustee rather than having the Financial Secretary in that position.
- Changing the rules for membership in the Bylaws, reducing the age to sign the book from 14 to 12 and removing the requirement for a financial contribution for voting membership.

Since our current Constitution requires the calling of a special meeting for Constitutional and Bylaws amendments, this meeting will come in two parts. The first part will be a "special meeting" where we address the proposed Constitutional amendments and Bylaw changes. Once that business has been conducted, the special meeting will adjourn and we will move directly into the "regular" annual meeting.

We will be dealing with several weighty and discussion-worthy issues in this meeting, so please come prepared by familiarizing yourself with the proposals and being ready for a longer-than-usual meeting. Also, please be prepared to have patience with your new moderator, who has been boning up on his Robert's Rules of Order but who also has the unenviable task of taking over for the most excellent Brian McDermott in this role.

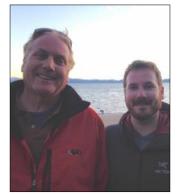
In Memoriam

The Rev. Matt Tittle, longtime member and friend of UUCUC, died on June 26, 2018. Matt first became part of UUCUC in the 1990's, before attending Meadville Lombard seminary and being ordained as a UU minister by this congregation in 2004. He then served congregations in Texas, New Jersey, and New Zealand.

A retired naval officer, he was also a marathon runner, a writer, an educator, and a perpetual student of life. He and his wife Gail co-authored the UU leadership curriculum *Harvest the Power*, as well as *Bless All Who Serve: Sources of Hope, Courage and Faith for Military Personnel and Their Families*, and he wrote the completely delightful children's book, *Stanley, the Very Fine Squirrel*, which we shared in a service in the Spring of 2018, as well as *Taking Back Faith*.

Tom Gillespie, a beloved member of UUCUC, died on October 7, 2018.

Tom's mother, Jean Gillespie, joined UUCUC when Tom was a child, and Tom remained a steadfast and generous supporter of the church all of his life. He was particularly dedicated to the Property Committee, donating his own hard work, the time of his employees from his business, Roland Realty, and financial resources to take care of our building.

His "Beans, Bluegrass, and Barbecue" auction party was one of the highlights of the year, with a live bluegrass band and Tom playing the spoons. He was a loving friend to many in the church and in the community, and involved in causes throughout the community, including the Urban League.

Bernadine Stake, a beloved long-time member of the church, died on February 23, 2019.

Bernadine ("Bernie") Stake and her husband Bob Stake signed the UUCUC membership book on March 17, 1968, to continue their UU commitment and to be active in Channing Murray. Bernadine later was on the board of Channing Murray. They raised their family as Unitarian Universalists and their grandson Ben Joselyn is a current UUCUC Board member. They attended services regularly, even as Bernadine's health declined, and she offered smiles and hugs to many.

Bernadine spent 36 years helping run the City of Urbana in various roles, including as an Urbana City Council member and on the Planning Commission. She completed her doctorate in education at University of Illinois. She did research on methods using Plato computer instruction in classrooms and on implementing non-sexist teacher training materials for sex equity in schools.

Accessibility

We wish to thank the congregation for their support in improving accessibility. This past year we added new tools, rearranged a practice and learned about an "invisible" challenge. We introduced the new Audio Everywhere Assistive Listening System which not only provides improved listening for those with hearing impairments but also extends the ability to stream the service throughout the entire church building. In addition, thanks to the ingenuity and hard work of Herb Hiestand with assistance of Charlie Wisseman we now have a new Name Badge Kiosk! The kiosk replaces our previous hazardous and inaccessible practice of storing the badges above the stairs. They also used some wood from the walnut tree harvested from our property! We also went through an informational period and officially



adopted a Fragrance Free Policy in order to widen our welcoming environment for people who struggle with chemical sensitivities. In the coming year we will be redoing the restrooms in the basement so we will have accessible facilities on our lower level. We look forward to continuing to create a truly welcoming, comfortable environment for all.

Building and Grounds (formerly Property)

This year the volunteer position of Property Chair was replaced with the position of Facilities Coordinator in an effort to provide more of an on-site presence for the management of our property. This change also resulted in the formation of a new Building and Grounds Advisory Team who will work with the Facilities Coordinator to assess needs and prioritize projects. Also under the responsibilities of the Facilities Coordinator is the function of Events Coordinator. This new position has the responsibility for all building events that are not committee related. Plans for this function include revising policies and documents related to building rentals and the development of a marketing plan in order to increase rental income.

Care Core

We meet monthly with our minister to monitor pastoral care needs & how we can support those in the congregation in need. We regularly keep in touch with a couple dozen folks, often people who haven't been able to attend church for awhile. This might mean phone calls, cards or home visits or any combination of those. This past year we hosted one memorial reception & will soon be helping at another that will not be held at the church. We also arranged meals for several church members throughout the year & coordinated transportation to medical appts for several others. With the very capable help of Anne Reeser, we initiated a "ride share" project where we try to match those in the congregation who need rides to church with



volunteer drivers. Herb Hiestand continues to lead the "Repair Core" group (which would love to be busier than they are). We led a worship service in February ("Walking Each Other Home") & have initiated a sub-Committee on Lay Ministry with the goal of sponsoring a Lay Ministry program in our church in the next year.

Finance Committee

It's been a pleasure to serve on the Finance Committee over the 2018-2019 budget year. A full report will follow later this year, but below are two items of great importance with respect to finance.

- 1. We successfully replaced our book keeper again this year. We hired a bookkeeping service rather than an individual bookkeeper this time. It has been initially more expensive than anticipated, but the fees are coming down as they learn our systems.
- Our treasurer, Gail Schiesser, accepted the call of the BOT to form an inter-committee task force to take over planning and managing the budget. From a functional standpoint this new task force usually includes 80% of the current Finance Committee along with others from Stewardship, Personnel, Religious Education, and your minister.

Leadership Committee

The Board of Trustees has requested an activation of a Leadership Committee, approved in Fall 2012. Priscilla Kron and Betsy Hunter are coordinating this effort. We have begun to gather input and made a brief presentation to the Committee Council in April, 2019. More to come in the fall! Note: The previous name was Leadership Committee, but we will be changing it. We're still finalizing a new name.

Membership Committee

The Membership Committee is extending invitations to young people in our church community to become members and to become more actively involved in leadership opportunities. The Membership Committee has also taken leadership in publication of a new photo church directory to support existing members and friends in more easily making connections with others in the church community. And the Membership Committee has worked cooperatively with the Accessibility Committee to create a safe and secure Name Badge Kiosk.

Music Program

The music program continues to be a vibrant part of both worship and the broader UUCUC experience. This year, we expanded our (new) tradition of hosting concerts at UUCUC, and we regularly experienced the joys of our own congregational musicians in Sunday services. From Children's Choir to CrUUners, from beginner to veteran, we offer musical experiences that are educational, spiritual, and meaningful for all.



Partner Church Committee

The Partner Church Committee had a wonderful year. We believe that the congregation understands much more about the partner churches in India and in Romania. The Church in Nongtalang in India built their new church and are improving on the building. The church in Romania, Szekelykal is also improving on their new addition to the old building. During the shared offering in December 2018, the congregation gave to Partner churches more than \$3,000. This is the best number ever. On April 7th, 2019, we offered an Indian Brunch which was very well attended. We made \$1339 on that event. We applaud the congregation for their generosity to the Partner Churches.

Personnel Committee

Two initiatives that are especially germane to the decisions the congregation will make at the annual meeting on May 5 are: identifying changing needs for staff, including adding staff and changing the responsibilities of current staff; and envisioning how this translates into the personnel budget for FY2020 that the congregation will approve at the annual meeting.

Racial Justice Project

RJP transitioned from a 2 year initiative to a regular group within the church and organized a number of justice oriented events since last spring. These included a very successful workshop on Critical Cultural Competency offered by Crossroads training (see picture), and meetings with local groups such as NAACP and representatives of the Champaign County Racial Justice Task Force. We organized a well received Sunday Worship Service titled "Don't Sleep Through the Revolution" on MLK weekend and supported a discussion group of the book "White Fragility" by Robin DiAngelo.



Religious Education

UUCUC entered an interim religious education period this year with a commitment to take a close look at its religious education history, present identity and religious education visions for the future. While exciting transformation work occurs, an engaging Sunday morning religious education program with seven classes and child care ran on Sunday morning for children and youth. Children and youth engaged in worship, play and learning through a variety of opportunities. Adult religious education classes led by our minister, interim director of religious education, community leaders, and UUCUC members/friends rounded out this vibrant religious education program.

Social Action Committee

This year, the Social Action Committee worked to find meaningful ways to deploy its expanded budget. We brought in an innovative collaborative budgeting process to allow thirty members to work together to invest over \$2,300 in important community initiatives. Additionally, we coupled with First Followers to help launch two transitional houses for formerly incarcerated persons, complete with programs aimed at lowering recidivism and rebuilding healthy lives. And finally, a new Immigration Task Force was formed. They have begun to partner with the CU Immigration Forum, CU Fair, and the Latino Family Liaison of Urbana School District #116 to support new initiatives and create opportunities for members and friends to both support and build relationships with immigrants in our community.

Trust Fund Trustees

At the 2018 Annual Meeting, the congregation amended its bylaws to charge the Trust Fund Trustees with considering the impact of their investments on the social good. Since that time, the Trustees adopted the Socially Responsible Investment (SRI) Guidelines that were developed by the church's SRI Task Force. In February, the Trustees reinvested all non-cash assets of the UUCUC General Trust Fund into SRI funds. Our new portfolio heavily emphasizes funds from Calvert, a firm that specializes in SRI investing. The new portfolio moves us meaningfully towards our guidelines, benefits from Calvert's focus and investor activism, and maintains reasonable expenses due to our low institutional rate.

Two Year Initiative to Create a Culture of Community Engagement

We worked on transforming existing Church structures while we brought in programs to build our capacity for community engagement. This year saw changes in the Social Action Committee that are helping it become an engine to turn our congregation's passions into action. We are also working closely with the strategic visioning and interim religious education task forces to build a future where the Church is deeply engaged with our wider community. The "We Wanna Woke" choir provided a series of workshops for the congregation to learn chants and songs that will ready us to be a unified force to lift the spirit and amplify the message of protests as they are called in the future. Additionally, we have hosted two workshops led by Karen Simms to help build a broader understanding of trauma, trauma informed care, develop better practices for community engagement, build resiliency tools, positive youth justice and good practices for engaging with community violence.

Stewardship Committee

The stewardship team is happy to report another great year of Supporting Our Vision. Pledges for the 2019-20 church year total \$450,000, an increase of nearly 6% over last year! Thanks to everyone for



making this sustained commitment to our church home.

UUA Communications

UUA Communications, formerly known as Denominational Affairs, is an advocacy for connecting to our larger UU world via visits to other UU Churches, using the resources of the UUA, enjoying a summer week at Camp Unistar in northern Minnesota and participating in the annual General Assembly (GA) of the Unitarian Universalist Association of Congregations. GA is the annual business meeting of the association and the host of hundreds of workshops, music events, worship services, displays and overall a grand reunion and party. It is a five-day event in late June of each year that attracts thousands of UUs. Regional Assembly was held in St. Louis and attended by our minister , and our Religious Education staff will be attending 2019 GA.

Worship Committee

The Worship Committee has continued to organize and support fine lay-led services during the regular church year. We are particularly proud of some of this year's offerings, which featured deeply meaningful reflections and personal stories from members of the congregation and guest speakers. In 2018, the Worship Committee for the first time took responsibility for summer services as well, and based on the success of last year this now becomes a permanent arrangement. As of now, five of the eight summer services are spoken for, we expect to fill out the lineup by the end of May, and we look forward to another great summer.

The Young Adult Group

We are contemplating leading another Sunday service some time since we had so much fun with the first! We also have ideas on having some sort of UU Life Skills series of workshops, either mentor or peer-trained as we have a lot of talented people in the congregation. We're just in the planning stages at this point.



Congregational Constitution and Bylaws Changes

Voting members of UUCUC will vote on modifications to the existing Constitution and Bylaws of the church. As our church has grown and we are moving to a more programmatic style of church management, we need to:

- 1. clarify certain requirements for governance of the church
- 2. realign the Constitution and Bylaws with current and future organizational needs for effective and efficient operation

Some of the major changes being voted on include:

- Modification of the existing Constitution and Bylaws to include all previously approved amendments
- Modification of the scope of the Minister responsibilities to include Chief of Staff role
 - \Rightarrow Constitution, Art. VII, Sec. 6 and
 - \Rightarrow Revision of Board of Trustees responsibilities in Bylaws, Art. VII, Sec. 7
- Modification of scope of certain positions:
 - \Rightarrow Financial Secretary position (Bylaws, Article V, sections 2-6),
 - \Rightarrow UU Trust Fund Trustees description (Bylaws, Article VIII, Sec. 2&5),
 - \Rightarrow Moderator (Bylaws, Art. III, Sec. 2),
 - \Rightarrow Clerk position (Bylaws, Art. IV, Sec. 2,3)
- Modification of membership requirements (Bylaws , Article I)
- Modification of scope of annual meeting and timing of committee reporting
 - \Rightarrow (Bylaws, Art. II, Sec. 1, and Art. X, Sec. 2)

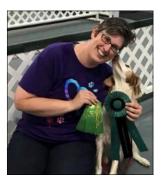
Slate of Nominees

ARTICLE IV: MEMBERSHIP

Section 1: All persons who are in sympathy with the purposes and programs of this Church may become members by meeting the requirements as stated in the Bylaws.

- b. At the call, the duties and the conditions of employment of the Minister(s) shall be stated in writing and shall be mutually agreed upon by the Minister(s) and the Board of Trustees., subject to the approval of the voting membership.
- c. b. The Minister is Chief of Staff. The Minister has authority to hire, supervise, discharge, and change the compensation of congregational staff, or implement other major personnel--related changes regarding congregational staff in consultation with the Personnel Committee. The Personnel Committee acts on behalf of the Board and in accordance with the Constitution, Bylaws, Board policies, and budgets established by the congregation.

Section 7: The Minister(s) shall maintain records of rites of passage performed and shall provide this information to the Board of Trustees at its request.

ARTICLE VIII: DISSOLUTION

Section 1: This corporation shall be dissolved by a threefourths vote of voting members present and voting at a Special Meeting duly called for this purpose.

Section 2: Title to real property shall revert to the Unitarian Universalist Association or its successor organization upon either the dissolution of the Church or non-use of that property for a period of one year.

Section 3: Disposition of personal property shall be at the discretion of the voting membership except that such disposition must be to charitable or religious organizations. However, personal property items donated by individual members may be returned to the donor or the donor's heirs.

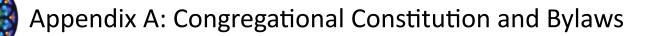

Management best practices for congregations the size of UUCUC highly recommend that the Minister act as Chief of Staff. A shift toward administrative processes with the Minister as Chief of Staff was initiated in 2016.

Recognition of the Minister as the Chief of Staff is part of Rev. Caplow's official call agreement and this change aligns the constitution with that document.

In a previous version of proposed changes to this section, compensation adjustment was stated as within the authority of the Minister. Based on feedback from the congregation and after discussion at the April 19, 2019 Board of Trustees meeting, that component was removed.



- a. All funds, other than real estate (Section 2), shall go to the organization or organizations which succeed the Church.
- b. If there is no successor organization within one year, all remaining funds shall be given to the Unitarian Universalist Association to be held in trust for ten (10) years for the establishment of a Unitarian Universalist Society congregation within Champaign County, Illinois.
- c. If no Unitarian Universalist Society-congregation is created within ten years, the Unitarian Universalist Association may use the money as its governing board determines.

ARTICLE IX: AMENDMENTS AND BYLAWS

Section 1: Amendments to this Constitution may be made by a vote of three-fourths of the voting members present and voting at an Annual Meeting of the congregation or a Special Meeting duly called for this purpose. Such amendments must have been stated in the written call for the meeting.

Section 2: Bylaws not in conflict with this Constitution may be adopted and amended by a two-thirds vote of the voting members present and voting at an Annual Meeting of the congregation or a Special Meeting duly called for this purpose. Such Bylaws must have been stated in the written call for the meeting.

Section 2: All gifts, devises, or bequests to the Unitarian Universalist Trust Fund shall be held by the Trustees for management and safekeeping.

Section 3: In so far as possible, the Trustees shall follow the intent of the donor as to the use of the monies entrusted to it. However, if questions of intent arise, the Board of Trustees of the Church shall make the final decision. The Trust Fund Trustees have full power to manage, rent, invest, sell, keep, or reinvest all or any part of the trust assets. All investments shall be made in accordance with the prudent person rule and with consideration of the impact that the investments will have on social good. The Trust Fund Trustees shall adopt and make available to the members of the congregation, socially responsible investment guidelines that the Trustees shall use in making their investment decisions. ¹⁴

Section 4: Unless designated otherwise, all funds will be deposited in the General Trust Fund. Monies in the General Trust Fund are held to provide future endowment for the Church and are disbursed in accordance with Section 5.

Section 5: An amount not to exceed 4.5% of the average General Trust Fund balance for the previous three years as of December 31st shall be transferred by the end of each fiscal year to the Financial Secretary for deposit to the Operating Fund of the Church.¹⁵

Section 5: Section 6: Specific Funds of the Unitarian Universalist Trust Fund may be created by majority vote of the Board of Trustees of the Church. Specific funds are created to serve specific purpose and terminate when the objective is achieved, or the project is completed.

- a. The Board of Trustees of the Church may terminate any Specific Fund based upon evaluation of its viability.
- b. Monies in Specific Funds will be disbursed to achieve the objectives of the fund.
- **c.** Any monies remaining in a terminated fund will be transferred to the General Trust Fund.

Section 6:Section 7: The Board of Trustees of the Church may accept or reject any restricted bequest or non-recurring gift subject to the limits set forth in the Constitution Article V, Section 3e.¹⁶

Section 7:Section 8: The promotion of long-term giving to the Church shall be the responsibility of the Board of Trustees of the Church.

ARTICLE XV: ARTICLE XVI: AMENDMENTS

Section 1: These Bylaws may be amended by a two-thirds (2/3) vote of those voting members present and voting at a congregational meeting of the Church.

Section 2: The amendments must be presented with the call to the meeting (Annual or Special) not less than ten (10) days before the meeting.

Section 3: Amendments may not be in conflict with the Constitution.

Section 4: If any provision of these Bylaws or application of these Bylaws is held invalid for any reason whatever, the remainder shall not be affected and shall remain in full force and effect.

Annual Meeting

Unitarian Universalist Church of Urbana Champaign

May 6, 2018

Call to Order and Verification of a Quorum

Brian McDermott, Moderator, called the meeting to order at 12:08 p.m. when Amy Robison, the Financial Secretary, established that there was a quorum with 109 voting members in attendance.

Finalization of the Agenda

The agenda was amended; Item XIII was divided into two items. XIII Voting on the proposal for the Social Action Two-Year Initiative. XIV. Consideration and vote of support for the Racial Justice Initiative Resolution. The agenda was accepted by consent.

In Memoriam

Cindy Loui read the names of seven members that died since the 2017 Annual Meeting:

Approval of Minutes from the Annual Meeting on May 7, 2017

The Minutes were accepted by the congregation by consent.

Acceptance of the Annual Report

The Annual Report was accepted by the congregation by consent.

Remarks by the Board of Trustees Chair

Julie Laut, Chair of the Board of Trustees, reported that one year ago, the congregation called Rev. Florence Caplow by unanimous vote, after two years of Interim ministry and an extensive search process.

Laut thanked the Board of Trustees, six of whom joined one year ago during a period of transition.

Laut reported a total of 312 members, 44 new members joining each of the last two years. The Stewardship Campaign increased giving by 11% and the Service Auction saw record-breaking income.

Laut highlighted accomplishments of the year, including the purchase of a new piano symbolizing our amazing music program, new voices from the pulpit under Rev. Caplow's leadership of the Shared Ministry Committee, and a shared offering donation of over \$5000 to Black Lives Unitarian Universalist (BLUU) in response to a UUA challenge.



Laut reported that Michele Grove will join the staff as Interim Director of Religious Education for a two-year period, and in June, a project will bring the entrance to the sanctuary into ADA compliance for accessibility.

Laut shared that the budget that will be voted on later in the meeting was informed by the mission of the church. With the funds, we will bring staff salaries up to mid-range of the mid-size congregation in our region according to UUA guidelines, remodel a bathroom in the basement to be accessible, fund new Religious Education initiatives, and support the ongoing work of the Racial Justice Initiative and Social Action Committee.

Consideration and Vote on the Proposed Mortgage

Gail Schiesser, Treasurer, described the commercial mortgage offer from Hickory Point Bank of a five-year note which will balloon in five years at 5.15%, with a payment of \$1450 per month and will leave approximately \$19,000 in principal remaining after five years.

Marilyn Ryan made the motion to authorize the Board of Trustees to execute the mortgage as presented by Schiesser; Kristi Mercer seconded the motion; the motion was approved.

Consideration and Vote on the 2018-2019 Annual Budget

Gail Schiesser, Treasurer, reviewed the budget highlights. The proposed budget is based on our UUCUC mission and goals. Income is projected to be \$617,681, which is a 26% increase over last year. The budget includes staff pay raises to the mid-range of Midsize II congregations according to the UUA guidelines, and an increase for the Office Administrator to full-time and Membership Coordinator to ³/₄ time. Social Action Committee funding has increased as well as Racial Justice funding. Other highlights include a salary reflecting the credentials of the Interim Director of Religious Education, increased Religious Education funding, and funding for accessibility improvements.

Ben Joselyn made the motion to accept the 2018-2019 Annual Budget as presented; Steve Troyer seconded the motion; the motion was approved.

Election of Officers, Elected members of Nominating Committee and Delegates to the General Assembly

No further nominations being made, the slate of nominees was accepted as presented.

Consideration of and Vote on the proposal to repurpose the budget set-aside of \$15,000 for demolition of the High Street House, to a set-aside for use toward renovation or demolition of the High Street House

Cliff Singer, Johnny Robinson and Libby Tyler did a broad study of the High Street House which is in critical need of renovation if it is to continue as a viable structure. Changing the budget set-aside from "demolition" to "demolition or renovation" will provide flexibility in the next year if decisions are agreed to by the congregation. Several members spoke in opposition to the proposal and several spoke in favor of the proposal to provide flexibility with the decision making.

A call to vote was approved.

A vote was taken by raised hands and the ayes had a 2/3 majority. The motion was approved.

Consideration of and vote on proposed amendment to the Bylaws Article XIV, Section 3

Lan Richart introduced the proposal recommended by the Socially Responsible Investment Task Force to invest UUCUC's assets to the maximum extent practicable to reflect our vision, values and principles. The Social Action Committee, Socially Responsible Investment Task Force, Finance Committee, Trust Fund Trustees, and Board of Trustees were involved in the process. The proposal



would ask Trust Fund Trustees to make investment decisions to use both the prudent person rule and give intentional consideration that the investment has on social good.

The UUA has had a commitment to this approach for more than 40 years. The Trust Fund Trustees will adopt guidelines that are developed to focus on social good and make them available to the congregation. The proposal is supported by the Board of Trustees and the Finance Committee.

Jenny Hunt made a motion to approve the proposed amendment to the Bylaws; Umeeta Sadarangani seconded; the motion passed unanimously.

Consideration of and vote on resolution proposing the installation of the Black Lives Matter banner

elizaBeth Simpson presented background on the efforts of the Racial Justice Initiative to create a Frequently Asked Questions (FAQ) document to invite discussion about installing a Black Lives Matter banner. In 2013 the Black Lives Matter Movement began, in 2015 the UUA made an Action of Immediate Witness, in 2016 the Racial Justice Two-Year Initiative was approved by the UUCUC congregation, which proposed the installation and dedication of a Black Lives Matter banner. In 2018, RJI contacted the local chapter of Black Lives Matter to invite feedback, and in April 2018 the Board of Trustees voted to approve the installation of a Black Lives Matter banner.

Brian McDermott read the proposed resolution.

One person spoke against the resolution. Several people spoke in support of the resolution.

A call to vote was approved.

A voice vote was taken; the resolution was approved.

Consideration and vote of support for the Racial Justice Initiative Resolution

Karla Peterson presented background of this proposal. In May of 2016, the congregation approved a two-year initiative titled "In Solidarity with Black Lives Matter; Examining White Privilege and Dismantling White Supremacy." The group that organized activities for this initiative was called the Racial Justice Initiative (RJI). When the proposal process started in January 2018 for the next initiative, a proposal was submitted to continue the RJI for another two years. However, RJI also applied for funding during the budget process and the congregation approved this budget, so RJI is no longer asking for the designation of the two-year initiative. Because of the importance and difficulty of this work, RJI would like a vote of continuing support of the group's continuing work, "Carrying Forward the Racial Justice Initiative to Dismantle White Supremacy."

Deanna Hence spoke about the work of educating ourselves about racial injustice and the desire to move into direct action in the community through partnerships. The group is asking for the congregation to affirm it's support for continuing our work and to show that we as a community are truly committed to these efforts.

Deanna Hence read the resolution.

Deanna Hence made the motion to approve the resolution; Doug Jones seconded; the motion was approved unanimously.

Voting on the proposal for the Social Action Two-Year Initiative

Ben Galewsky presented the proposal to spend the next two years building our capacity as a church to address a range of issues, specifically, creating an intentional culture of community engagement so that we serve as an effective resource for social justice in East Central Illinois. The proposal is titled "Creating a Culture of Community Engagement at UUCUC."



Jenny Hunt made a motion to approve the proposal, Jim Hannum seconded the motion; the motion was approved unanimously.

Proposed Amendment to the UUCUC Bylaws Article XIV, Section 3., Unitarian Universalist Trust Fund

Article XIV, Section 3 of the bylaws, currently reads:

"In so far as possible, the Trustees shall follow the intent of the donor as to the use of the monies entrusted to it. However, if questions of intent arise, the Board of Trustees of the Church shall make the final decision. The Trust Fund Trustees have full power to manage, rent, invest, sell, keep, or reinvest all or any part of the trust assets. **All investments shall be made in accordance with the prudent person rule**."

We, the Socially Responsible Investment Task Force, propose that the final sentence be amended to the following:

"All investments shall be made in accordance with the prudent person rule and with consideration of the impact that the investments will have on social good. The Trust Fund Trustees shall adopt and make available to the members of the congregation, socially responsible investment guidelines that the Trustees shall use in making their investment decisions."

Proposed Resolution to install Black Lives Matter Banner

Unitarian Universalist Church of Urbana-Champaign Support the Black Lives Matter Movement

Whereas, the 2015 General Assembly of the Unitarian-Universalist Association called member congregations to support the Black Lives Matter movement;

Whereas, the congregation of UUCUC has been actively engaged in a two-year racial justice initiative, seeking to educate ourselves about racial injustice, explore our implicit racial attitudes and biases, and examine white supremacy within our community, congregation and denomination;

Whereas, the congregation of UUCUC desires to support the Black Lives Matter movement and Black-led racial justice organizations such as Black Lives of Unitarian Universalism;

Therefore, Be It Resolved that UUCUC will publicly display a Black Lives Matter banner to express our support for the Black Lives Matter Movement and the activist campaign to end violence and systemic racism against black people.

Racial Justice Initiative Resolution

Background: In May 2016, the congregation voted to support a two-year initiative titled: "In Solidarity with Black Lives Matter: Examining White Privilege and Dismantling White Supremacy." The tasks of this effort have been organized by a group named the Racial Justice Initiative (RJI).

Because of the importance of these issues, RJI decided to reapply for another two-year initiative when the proposal process started in January/February 2018. However, RJI also applied for regular funding in the budget process and was grateful to learn funding as an ongoing working group has been included in this year's budget. RJI thus no longer needs the funding reserved for the next two-year initiative and has decided to no longer ask for this designation (i.e., being the next two-year initiative).

However, because of the high importance of racial justice issues and the difficulty of this work, RJI would like a vote of continuing support from the congregation for these activities, which are outlined in the document titled: "Carrying Forward the Racial Justice Initiative to Dismantle White Supremacy."

The resolution that we would like the congregation to vote to support is as follows:

We, the members of the Unitarian-Universalist Church of Urbana-Champaign, affirm the importance of our efforts to educate ourselves about racial injustice, white privilege, and implicit racial bias, and to work to dismantle white supremacy in our schools, our church, our workplaces, and our communities. We are all impacted by racial injustice regardless of our racial/ethnic backgrounds and we wish to lift up the importance of this difficult work for the betterment of our church and society. We support the Racial Justice Initiative to organize this important effort as an ongoing working group within our church.
